**SECOND AMENDMENT TO TRADEMARK AND TRADEMARK  
APPLICATIONS SECURITY AGREEMENT**

This Second Amendment to Trademark and Trademark Applications Security Agreement (this "Amendment") is made as of the 11 day of June, 2009 by and between

**INFORMATION TODAY, INC.**, a New Jersey corporation, having an address 143 Old Marlton Pike, Medford, New Jersey 08055 (the "Borrower"), and

**RBS CITIZENS, N.A.**, successor by merger with CITIZENS BANK OF MASSACHUSETTS, a Massachusetts bank, with an address at 28 State Street, 15th Floor, Boston, Massachusetts 02109 (the "Bank")

in consideration of the mutual covenants herein contained and benefits to be derived herefrom.

**W I T N E S S E T H:**

WHEREAS, the Borrower executed and delivered a Trademark and Trademark Applications Security Agreement dated as of February 7, 2006 (as amended from time to time, the "Security Agreement") and filed with the United States Trademark Office in Reel 3264 Frame 0408 in favor of the Bank, pursuant to which the Borrower pledged, assigned and granted a security interest in favor of the Bank in certain Trademark Collateral (as defined therein); and

WHEREAS, the Borrower has acquired additional Trademark Collateral and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Trademark Collateral in favor of the Bank.

NOW, THEREFORE, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Security Agreement.
2. Amendment to Exhibit A. Exhibit A to the Security Agreement is hereby amended by adding thereto, the Trademark Collateral set forth on Exhibit A, annexed hereto and incorporated herein by reference.
3. Miscellaneous:
  - A. Except as provided herein, all terms and conditions of the Security Agreement remain in full force and effect. The Borrower hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants therein contained.
  - B. This Amendment may be executed in several counterparts and by each party on a separate counterpart, each of which when so executed shall be an original and all which together shall constitute one instrument.

C. This Amendment covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.




