NUNC PRO TUNC ASSIGNMENT

WHEREAS, the parties have agreed to transfer all rights in the Marks to Cilag GmbH International, a Swiss corporation, pursuant to the document entitled Agreement Regarding Transfer of Trademarks and Production Intangibles dated July 1, 2005; and

WHEREAS, Johnson & Johnson GmbH, a German corporation, having a principal business address at Kaiserwerther Strasse 270, 40474 Düsseldorf, Germany ("Assignor"), is the owner of the trademark PENATEN and the U.S. federal registrations thereof, Reg. Nos. 663,679 and 731,272; and

WHEREAS, Cilag GmbH International, a corporation of Switzerland, having an address at Landis & Gyr Strasse 1, CH-6300, Zug, Switzerland ("Assignee"), acquired all rights, title and interest in and to the trademark PENATEN, the goodwill of the business symbolized thereby, and the registrations thereof, Nos. 663,679 and 731,272, from Assignor effective as of January 1, 2005.

NOW, THEREFORE, good and valuable consideration being extant, Assignor has assigned and hereby assigns to Assignee, **effective as of January 1, 2005**, all of its rights, title and interest in and to the trademark PENATEN, the goodwill of the business symbolized thereby and the registrations thereof, Reg. Nos. 663,679 and 731,272.

Assignor further assigns to Assignee all right to sue for, to receive and to hold damages and profits accruing from past infringement of the service mark PENATEN.

Assignor further warrants that there are no licenses, encumbrances or other agreements, either written, oral or implied, relating to the mark PENATEN of which Assignee is not aware, and that it believes it has good and valid title to the marks to assign to Assignee.
