TRADEMARK ASSIGNMENT

WHEREAS, Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A., AKA Rabobank Nederland, a limited liability company of the Netherlands with offices at Croeselaan 18, Utrecht 3251 CB, NETHERLANDS ("Assignor"), owns the mark FARMSTRONG and U.S. Trademark Registration No. 3,352,910 therefor (hereinafter this trademark and trademark registration shall be referred to collectively as the "Mark");

2. Assignor further agrees to execute such further documents reasonably required by Assignee to secure and enforce the rights granted to Assignee under this Assignment.
