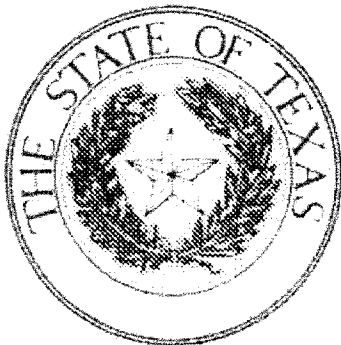

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, PAVESTONE COMPANY, a Texas corporation subject to the provisions of the Texas Business Corporation Act, does hereby adopt and submit the following Articles of Amendment for the purpose of reflecting an amendment to Article I of the corporation's originally filed Articles of Incorporation, said amendment having been heretofore authorized by the Board of Directors and Shareholders of Pavestone Company in the manner provided in the Texas Business Corporation Act.

1. The name of the corporation is PAVESTONE COMPANY.
2. The following amendment to the Articles of Incorporation was adopted on: February 1, 1995.

ARTICLE ONE is amended to read:

"The name of the corporation is PAVESTONE TEXAS REALTY, INC."

3. The number of shares of the corporation outstanding and entitled to vote at the time of such adoption was 80,000.
4. The number of shares voted for such amendment was 80,000; the number of shares voted against such amendment was 0.
