ARTICLES OF MERGER

OF

SHORT STOP, L.L.C.

WITH AND INTO

NATIONAL SAFETY ALLIANCE, INCORPORATED

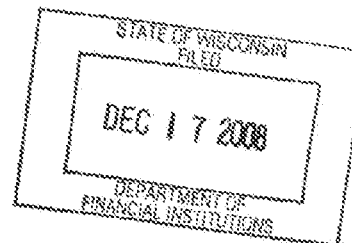
Pursuant to Section 183.1204 of the Wisconsin Limited Liability Company Act (the "WLLCA"), National Safety Alliance, Incorporated, a Tennessee corporation ("NSAI"), hereby certifies as follows:

FIRST: Pursuant to Section 183.1201 of the WLLCA and Section 48-21-110 of the Tennessee Business Corporation Act (the "TBCA"), at the Effective Time and upon the terms and conditions as set forth in the Plan of Merger, dated December 12, 2008, by and between NSAI and Short Stop, L.L.C., a Wisconsin limited liability company ("Short Stop"), attached hereto as Exhibit A (the "Plan of Merger"), Short Stop shall be merged with and into NSAI (the "Merger"). NSAI shall be the surviving corporation of the Merger, and NSAI is not an indirect wholly-owned subsidiary or parent corporation.

SECOND: The effective date of the Merger shall be 11:59 p.m. Eastern Time on December 31, 2008 (the "Effective Time").

THIRD: As required by and pursuant to Section 183.1202 of the WLLCA, the terms of the Limited Liability Company Operating Agreement of Short Stop, and Section 48-21-104 of the TBCA, the Plan of Merger was duly adopted and approved by (i) the board of managers of Short Stop on December 12, 2008, (ii) the board of directors of NSAI on December 12, 2008, and (iii) the board of directors of ChoicePoint Services Inc., a Georgia corporation, in its capacity as the sole shareholder of NSAI and sole member of Short Stop, on December 12, 2008.

FOURTH: As of the Effective Date, neither Short Stop nor NSAI has in its name any fee simple ownership interest in any real property located in the State of Wisconsin.

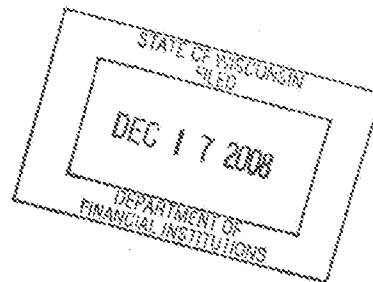

PLAN OF MERGER
OF
SHORT STOP, L.L.C.
WITH AND INTO
NATIONAL SAFETY ALLIANCE, INCORPORATED

I. Constituent Corporations and Merger.

Pursuant to Section 48-21-110 of the Tennessee Business Corporations Code (the "TBCA") and Section 183.1201 of the Wisconsin Limited Liability Company Act (the "WLLCA"), at the Effective Time as described below and upon the terms and conditions as set forth in this plan of merger (the "Plan of Merger"), Short Stop, L.L.C, a Wisconsin limited liability company ("Short Stop"), shall be merged with and into National Safety Alliance, Incorporated, a Tennessee corporation ("NSAI"), each of Short Stop and NSAI being a wholly-owned subsidiary of ChoicePoint Services Inc., a Georgia corporation ("ChoicePoint Services"). NSAI shall be the surviving corporation of such merger (the "Merger").

II. Manner and Basis of Converting Shares.

Upon the Merger becoming effective in accordance with Section III below, all of the membership interests of Short Stop outstanding immediately prior to the effectiveness of the Merger shall be cancelled and eliminated. Since ChoicePoint Services is the sole member of Short Stop and the sole shareholder of NSAI, no additional shares of NSAI shall be issued.

III. Effective Time.

Pursuant to Section 48-21-107 of the TBCA and Section 183.1204 of the WLLCA, NSAI will cause articles of merger to be executed and filed with the Secretary of State of the State of Tennessee, and with the Department of Financial Institutions of the State of Wisconsin. The Merger shall become effective on December 31, 2008 at 11:59 p.m. Eastern Time (the "Effective Time").

IV. Counterparts.


This Plan of Merger may be executed in multiple counterparts, including by means of facsimile or electronic communication, and each counterpart hereof shall be deemed to be an original instrument, but all such counterparts together shall constitute one and the same agreement.

IN WITNESS WHEREOF, the parties hereto have caused this Plan of Merger to be executed as of the 12th day of December, 2008.
