CONFIRMATORY ASSIGNMENT – TRADE-MARKS

The Assignor hereby undertakes at any time upon reasonable request to execute such documents and take such further actions as may be necessary to evidence the assignment of the Trade-marks to the Assignee, and to enable the Assignee to obtain and maintain the applications and registrations for the Trade-marks, all without further consideration but at the sole expense of the Assignee.
