CERTIFICATE OF MERGER**OF****STRATIS BUSINESS CENTERS, INC.**
(a South Carolina corporation)**WITH AND INTO****SBC ACQUISITION CORP.**
(a Delaware corporation)

The undersigned corporation organized and existing under the laws of the State of Delaware,
DOES HEREBY CERTIFY:

FIRST: That the names and states of incorporation of the corporations that are parties to the merger are Stratis Business Centers, Inc., a South Carolina corporation ("Stratis"), and SBC Acquisition Corp., a Delaware corporation ("SBC").

SECOND: That an Agreement and Plan of Merger (the "Merger Agreement") by and among the parties to the merger has been approved, adopted, certified, executed and acknowledged by each of Stratis and SBC in accordance with Section 252(c) of the Delaware General Corporation Law.

THIRD: That SBC Acquisition Corp., a Delaware corporation, is the surviving corporation of the merger.

FOURTH: That the Certificate of Incorporation of SBC Acquisition Corp., a Delaware corporation, which shall survive the merger in all respects, shall be the Certificate of Incorporation of the surviving corporation, and that such Certificate of Incorporation shall be amended by deleting Paragraph No. 1 in its entirety and inserting in lieu thereof a new Paragraph No. 1 to read as follows:

"1. The name of the Corporation is Stratis Business Centers, Inc. (the "Corporation")."

FIFTH: That the executed Merger Agreement is on file at an office of the surviving corporation, the address of which is 100 Manhattenville Road, 4th Floor, Purchase, New York 10577.

SIXTH: That a copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder of Stratis or SBC.

SEVENTH: The authorized capital stock of Stratis consists of one million (1,000,000) shares of common stock.

EIGHTH: The authorized capital stock of SBC consists of one thousand (1,000) shares of common stock, par value \$.01 per share

NINTH: That this Certificate of Merger shall be effective at 6:00 p.m., New York City time, on April 20th, 2001.

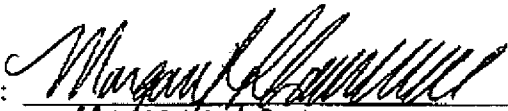
