## ASSIGNMENT AND ASSUMPTION OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS (this "Assignment") is made and entered into this 29<sup>th</sup> day of June, 2009 by and between GLOBAL FILM & PACKAGING CORPORATION, an Ohio corporation with principal offices located at 29550 Detroit Road, Suite 102 Westlake, Ohio 44145 (hereinafter referred as "Assignor") and ACCUTECH FILMS, INC., an Ohio corporation with principal offices located at c/o Clondalkin Group, Inc., 601 Walnut Street, Suite 965, Philadelphia, Pennsylvania 19106 ("Assignee").

### Background

WHEREAS, Assignor is the owner of the United States trademarks, trademark applications, trademark registrations, and common law trademarks set forth in Schedule A attached hereto and incorporated herein by reference, and any and all goodwill associated with any of the same (collectively, the "Trademarks"); and

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement dated the date hereof, pursuant to which Assignor has agreed to sell, transfer and assign to Assignee substantially all of the assets of Assignor, including without limitation, all of Assignor's right, title and interest in and to the Trademarks; and

WHEREAS, Assignor and Assignee desire to enter into this Assignment to memorialize the sale, transfer and assignment to Assignee of all of Assignor's right, title and interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the parties hereto hereby agree as follows:

1. Assignor does hereby sell, assign, transfer, and convey unto Assignee, its successors and assigns, and Assignee does hereby accept, all of Assignor's right, title, and interest in and to the Trademarks, the goodwill of the business of Assignor symbolized by the Trademarks, and the registrations thereof, to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment and sale not been made.

2. Assignor further transfers and assigns to Assignee, and Assignee does hereby accept, all causes of action, rights, and remedies which may have arisen under (the final dispositions of which have not been fully effectuated) or which are arising under the Trademarks prior to or after the date hereof, and all rights to damages and profits, due or accrued, arising out of or related to any past infringement claims (the final dispositions of which have not been fully effectuated) relating to the Trademarks, and the right to sue for recovery of the same damages and profits.

3. Assignor and Assignee hereby agree to, and shall, execute and deliver such further instruments of transfer and conveyance and take such action and deliver such other documents,

certifications and further assurances as may reasonably be required to effect and, where necessary, register the transfer and conveyance of the foregoing, and Assignor and Assignee hereby agree to, and shall, fully cooperate with each other in furtherance of the same.

4. This Assignment may be executed in one or more counterparts (and by facsimile signature), each of which will be deemed to be an original copy of this Assignment, and all of which, when taken together, will be deemed to constitute one and the same instrument.





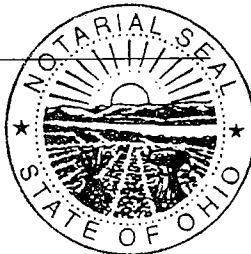
