ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK, dated March 24, 2009 ("Assignment"), is made by LNT ACQUISITION, LLC. (Assignor), a Delaware limited liability company, for the benefit of LF USA INC. ("Assignee") a Delaware corporation.

WHEREAS, Assignor is the owner of all right, title and interest in the trademarks listed on Schedule A attached hereto, including all common law rights, all applications and registrations therefore, and all goodwill associated therewith (the "Trademarks");

WHEREAS, Assignor has agreed to assign, transfer and convey all right, title and interest in and to the Trademarks to Assignee and Assignee has agreed to acquire all of Assignor's right, title and interest in and to the Trademarks.

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, intending to be legally bound, hereby agrees as follows:

1. Assignor does hereby assign, transfer, convey and set over to Assignee all of its right, title and interest in the Trademarks, including common law rights in the United States of America, together with the goodwill of the business symbolized by said Trademarks, all applications and registrations thereof and any renewal rights, revival rights or reinstatement rights therein, that portion of the business to which any intent-to-use applications relate, any common law rights to such Trademarks, and the exclusive right to enforce the Trademarks in the United States; the aforesaid transferred rights, title and interest to be held and enjoyed by Assignee, its successors, legal representatives and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.

2. Assignor hereby agrees to execute, at Assignee's expense, all instruments, documents and papers and to perform such other proper acts as Assignee, its successors or assigns may deem reasonably necessary to secure to Assignee, its successors or assigns the rights hereby assigned.

3. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York and the applicable federal laws of the United States of America.

4. This Assignment may be signed in any number of counterparts, each of which shall be an original with the same effect as if the signatory thereto and hereto were upon the same instrument.
