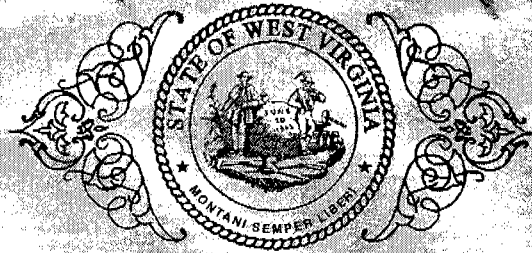

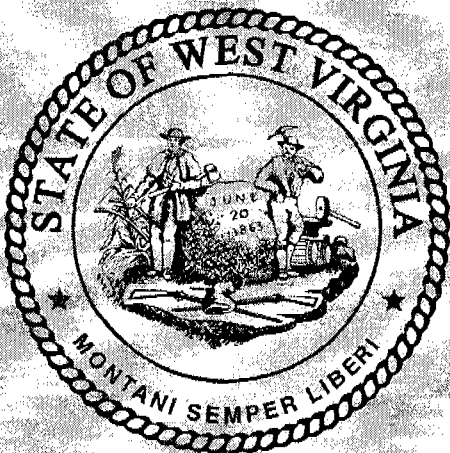

The undersigned limited liability companies, pursuant to Section 31B-9-905 of the West Virginia Uniform Limited Liability Company Act (the "Act"), hereby execute the following articles of merger (the "Articles of Merger") and set forth the following:

1. The parties to these Articles of Merger are:

a. Information Manufacturing LLC, a limited liability company organized and existing under the laws of the State of West Virginia ("Information Manufacturing"). Information Manufacturing was incorporated as a West Virginia corporation on January 9, 1998 and was converted to a West Virginia limited liability company on December 3, 2007 upon the filing of a Statement of Conversion with the Secretary of State of the State of West Virginia.

b. Information Manufacturing Acquisition, L.L.C., a limited liability company organized and existing under the laws of the State of Delaware ("Information Manufacturing Acquisition"). Information Manufacturing Acquisition was formed as a Delaware limited liability company on August 20, 2007 upon the filing of a Certificate of Formation with the Secretary of State of the State of Delaware. Information Manufacturing Acquisition has not filed an application for authority with the Secretary of State of the State of West Virginia.

2. A plan of merger has been approved and signed by each of Information Manufacturing Acquisition and Information Manufacturing.

3. Information Manufacturing shall be the surviving limited liability company of the merger contemplated hereby and following the merger shall continue to be governed by the laws of the State of West Virginia. The address of Information Manufacturing within the state of West Virginia following the merger shall be:

4. The effective date of the merger provided for herein shall be the date on which these Articles of Merger are filed with the Secretary of State of the State of West Virginia (the "Effective Time").
