SECOND AMENDED AND RESTATED TRADEMARK COLLATERAL ASSIGNMENT

INSTRUMENT OF JOINDER

THIS INSTRUMENT OF JOINDER ("Joinder") is executed as of July 27, 2009, by President Riverboat Casino-Missouri, Inc., a Missouri corporation ("Joining Party"), and delivered to Barclays Bank PLC, as Administrative Agent ("Administrative Agent"), pursuant to the Second Amended and Restated Trademark Collateral Assignment dated as of December 14, 2005 made by Pinnacle Entertainment, Inc., a Delaware corporation (the "Borrower"), and each of the other Grantors party thereto (each a "Grantor" and collectively the "Grantors") in favor of the Administrative Agent and the Lenders described therein (the "Trademark Assignment"). Terms used but not defined in this Joinder shall have the meanings defined for those terms in the Trademark Assignment.

RECITALS

(a) The Trademark Assignment was made by the Grantors in favor of the Administrative Agent for the ratable benefit of the Lenders that are referred to in the Trademark Assignment.

(b) Joining Party is a Restricted Subsidiary of Borrower and heretofore executed and delivered a Second Amended and Restated Collateral Assignment Instrument of Joinder effective as of March 13, 2007 ("Prior Joinder"), as required pursuant to Section 6.10(c) of the Second Amended and Restated Credit Agreement.

(c) The Prior Joinder has not been located and Joining Party is executing this Joinder to replace the Prior Joinder.

(d) Joining Party expects to realize direct and indirect benefits as a result of the availability to Borrower of the credit facilities under the Second Amended and Restated Credit Agreement.

NOW THEREFORE, Joining Party agrees as follows:

AGREEMENT

(1) Upon execution and delivery hereof, the Prior Joinder shall be and be deemed cancelled and terminated and of no further force or effect.

(2) By this Joinder, Joining Party becomes a "Grantor" under and pursuant to Section 10 of the Trademark Assignment. Joining Party agrees that, upon its execution hereof, it will become a Grantor under the Trademark Assignment with respect to all Obligations of Borrower heretofore or hereafter incurred under the Loan Documents, and will be bound by all terms, conditions, and duties applicable to a Grantor under the Trademark Assignment.

(3) Attached hereto as Schedule I is a complete list of all of Joining Party's Trademarks registered with the USPTO as of the date hereof.

(4) The effective date of this Joinder is the date first set forth above.


