**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 23, 2009 ("Effective Date") executed by SunTrust Bank, as Administrative Agent, with its principal office at 303 Peachtree Street N.E., Atlanta, GA 30308 ("Secured Party"), and FGX International Inc., a Delaware corporation, with its principal office at 500 George Washington Highway, Smithfield, Rhode Island 02917 ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement (the "Trademark Security Agreement") by and between Grantor and Secured Party dated December 19, 2007, Grantor assigned and pledged to Secured Party, and granted to Secured Party a continuing security interest in and to all of Grantor's right, title and interest in and to all trademarks, service marks, trade names, trade dress or other indicia of trade origin, trademark and service mark registrations, and applications for trademark or service mark registrations and any renewals thereof, whether owned by Grantor (collectively, the "Trademark Collateral");


WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on December 21, 2007, at Reel 003684, Frame 0159; and

WHEREAS, based on certifications made by the Grantor pursuant to the terms of the Credit Agreement, the Secured Party is authorized to release its security interest in the trademark registration and applications set forth on Schedule A attached hereto (the "Released Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby grants, assigns and conveys, without recourse or warranty, to Grantor all of its rights, title and interest in the Released Trademarks, and terminates, cancels and releases any and all security interests or liens it has against the Released Trademarks.
