RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated July 30, 2009 by Bank of Montreal, as Administrative Agent, as hereinafter described;

WITNESSETH:

WHEREAS, Bank of Montreal, as Administrative Agent, a Canadian chartered bank, for the benefit of the Secured Creditors as defined in the Trademark Collateral Agreement as referred to below (in such capacity, hereinafter referred to as the "*Administrative Agent*") with its mailing address at 115 South LaSalle Street, Chicago, Illinois 60603, and METRO CARS, INC., a Michigan corporation (the "*Debtor*") with its mailing address at 24957 Brest Road, Taylor, Michigan 48180, are parties to a certain Trademark Collateral Agreement dated August 18, 2006 which was recorded in the United States Patent and Trademark Office on August 22, 2006 at Reel 003374, Frame 0368, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademarks*"); and

WHEREAS, the Debtor has requested that the Administrative Agent release its security interests in the Trademarks and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Administrative Agent hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Administrative Agent, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) Each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.
