

WHEREAS:

Assignor hereby assigns unto the Assignee, its successors and assigns, all right, title and interest in and to the Trademarks including, but not limited to, all common law rights in the Trademarks together with the goodwill attaching to or associated with the Trademarks to hold unto Assignee absolutely, including all federal and state trademark registrations thereof and applications therefor. Assignee shall have the sole right to sue and collect damages and/or profits for both past and present infringements of the Trademarks.


