TRADEMARK ASSIGNMENT

This Trademark Assignment is made as of the 23 day of July by and between Cornerstone Enterprises, LLC ("Cornerstone") a Delaware corporation doing business at 2407 East Skelly Drive, Tulsa, Oklahoma 74105 and Reckitt Benckiser Inc., a Delaware corporation doing business at 399 Interpace Parkway, Parsippany, New Jersey 07054 ("RB");

WHEREAS, RB has adopted and has used since at least as early as 1979, and is the owner of the phrase YES! as a trademark for laundry cleaning products under U.S. Registration Number 1,181,761 and subsequently YES as a trademark for laundry cleaning products under U.S. Registration Number 3,178,551; and the phrase LAVENDER SACHET as a trademark for laundry softener products under U.S. Registration Number 1,190,379 (the "TRADEMARKS");

WHEREAS, Cornerstone wishes to acquire the TRADEMARKS in the US, the registrations therefore, the trade dress and copyrights associated with the most recent commercial use of the TRADEMARKS, and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, RB hereby sells, assigns, and transfers to Cornerstone all of RB's right, title and interest in and to the TRADEMARKS in the US, the registration therefore, the trade dress and copyrights associated with the most recent commercial use of the TRADEMARKS, and the goodwill associated therewith, as well as all of RB's right, title and interest in and to any and all claims and demands it may have, at law or in equity, for past infringement of the TRADEMARKS.

RB represents to Cornerstone that the TRADEMARKS are being transferred without lien or encumbrance; and further represents that, to the knowledge of RB, there is no litigation of any kind involving the TRADEMARKS.

RB acknowledges that they will be responsible for any liabilities which arise from events associated with the TRADEMARKS prior to date of this Assignment and that they will further be liable for any liabilities which arise in the future from product which can be proven to have been sold by them prior to the date of this Assignment.

RB makes no other representation, warranty or statement regarding the TRADEMARKS or any products or services related to the TRADEMARKS.
