

Articles of Amendment of Domestic For-Profit Corporation

Pursuant to the provisions of Title 29, Chapter 1 of the Code of Laws of the District of Columbia, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Name of the Business Corporation:

2. The following Amendment to the Articles of Incorporation was advised by the directors and adopted by shareholders of the corporation on July 22, 2009 _____ in the manner prescribed by the Code of Laws on the District of Columbia.

The name of the Corporation is hereby changed to: World Color Lanman Corp.

3. Amendment has been adopted in the following manner:
