TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement") is entered into between Industrias Auxiliares Faus S.L. ("Assignor"), with its principal place of business at Avinguda de la Vall d'Albaida 53, 46702 Gandia, Valencia, Spain, and Empire Today, LLC ("Assignee"), with its principal place of business at 333 Northwest Avenue, Northlake, Illinois 60164.

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark VISIONS and the corresponding pending trademark application for the VISIONS mark filed on May 23, 2007 in the United States Patent and Trademark Office (U.S. Application Serial No. 77/184,490) for laminate flooring (collectively referred to as the "Trademark"), as well as the goodwill symbolized by and associated with the Trademark; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademark and the associated goodwill.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties hereby agree as set forth below.

1. Assignment. In consideration of the payment described below, Assignor hereby sells, assigns, transfers, and conveys to Assignee all right, title and interest in and to the Trademark, together with the associated goodwill.
2. Assignment Price. The assignment price for Assignor's assignment of the Trademark and the associated goodwill to Assignee is Two Thousand, and Ninety Dollars (US\$2,090), to be due and payable from Assignee to Assignor in a single lump sum at the time this Agreement is fully executed.
3. Recordal of Assignment. Assignor authorizes the Commissioner for Trademarks and other empowered officials of the United States Patent and Trademark Office to record this Agreement against U.S. Application Serial No. 77/184,490.
4. Counterparts. This Agreement may be executed in duplicate counterparts, each of which when executed shall be deemed to be an original, and all of which when taken together shall constitute one and the same instrument.

IN WITNESS WHEREOF, the parties have executed this Trademark Assignment Agreement, effective as of December 12, 2008 or the date on which it is fully executed, whichever is earlier.

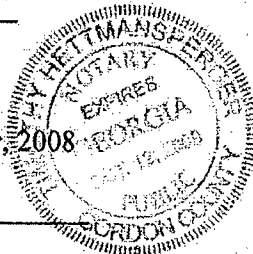

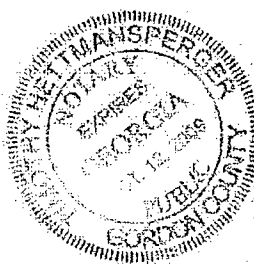
