**AMENDED AND RESTATED SECOND LIEN INTELLECTUAL PROPERTY
SECURITY RELEASE AGREEMENT**

This AMENDED AND RESTATED SECOND LIEN INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (the "*Amended and Restated Second Lien IP Security Release*") is made as of July 2, 2009, by Bank of America, N.A., as second lien collateral agent (the "*Collateral Agent*") for each of the Secured Parties (as defined in the Credit Agreement referred to below), in favor of Solo Cup Company; Solo Cup Investment Corporation; P.R. Solo Cup, Inc.; SF Holdings Group, Inc.; Solo Manufacturing LLC; Lily-Canada Holding Corporation; and Solo Cup Operating Corporation (collectively, the "*Grantors*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Second Lien Credit Agreement and the Second Lien IP Security Agreement (as defined below).

WHEREAS, Solo Cup Company, a Delaware corporation, entered into a Second Lien Credit Agreement dated as of March 31, 2006, as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Second Lien Credit Agreement*", with Solo Cup Investment Corporation, a Delaware corporation, the Lenders party thereto from time to time and Bank of America, N.A., as Administrative Agent;

WHEREAS, as a condition precedent to the making of Term Loans by the Lenders, each Grantor executed and delivered to the Collateral Agent (i) that certain Second Lien Security Agreement dated March 31, 2006 made by the Grantors (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Second Lien Security Agreement*") pursuant to which each Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in such Grantor's right, title and interest in and to the Collateral and (ii) that certain Second Lien Security Intellectual Property Security Agreement dated March 31, 2006 made by the Grantors (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Second Lien IP Security Agreement*");

WHEREAS, the Second Lien IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on April 20, 2006 at Reel 017492 and Frame 0618 and on June 14, 2006 at Reel 017782 and Frame 0307; with the Trademark Division of the United States Patent and Trademark Office on April 20, 2006 at Reel 003293 and Frame 0384; and with the United States Copyright Office on April 24, 2006 in Volume 3537 and Document No. 574;

WHEREAS, in accordance with the terms of the Payoff Letter (the "*Payoff Letter*") dated June 27, 2007 and given by the Collateral Agent, the obligations secured by the Collateral have been repaid or otherwise satisfied to the extent set forth in such Payoff Letter;

WHEREAS, pursuant to a certain Second Lien Intellectual Property Security Release Agreement dated April 17, 2009 (the "*Second Lien IP Security Release*") the Collateral Agent released its security interest in each Grantor's right, title and interest in and to the Collateral identified in the Second Lien IP Security Release;

WHEREAS, Solo Management Company was dissolved on December 29, 2006;
and

WHEREAS, the Collateral Agent and the Grantors now desire to amend and restate the Second Lien IP Security Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent and the Grantors hereby agree that the Second Lien IP Security Release is hereby amended and restated to read as follows:

SECTION 1. Release of Security Interest. The Collateral Agent hereby terminates and releases in its entirety its security interest in all of each Grantor's right, title and interest in and to the following:

- (i) the patents and patent applications set forth in Schedule A hereto;
- (ii) the trademark and service mark registrations and applications set forth in Schedule B hereto, together with the goodwill symbolized thereby;
- (iii) the copyright registrations and applications and exclusive copyright licenses set forth in Schedule C hereto;
- (iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor's accruing thereunder or pertaining thereto;
- (v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- (vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral.

SECTION 2. Recordation. The Collateral Agent hereby authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Amended and Restated Second Lien IP Security Release.

SECTION 3. Execution in Counterparts. This Amended and Restated Second Lien IP Security Release may be executed and delivered (including by facsimile transmission) in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4. Governing Law. This Amended and Restated Second Lien IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
