

AGREEMENT OF MERGER

This Agreement of Merger (the "Agreement"), adopted in accordance with Title 13, section 251, Virgin Islands Code, executed as of the 1st day of October, 2008, by and between Cruzan Viril Ltd., a U.S. Virgin Islands corporation ("Cruzan") and Leaf Acquisition Ltd., a U.S. Virgin Islands corporation ("Leaf").

WITNESSETH:

WHEREAS, Leaf owns 100% of the issued and outstanding shares of capital stock of Cruzan; and

WHEREAS, the shareholder of Leaf desires to cause Cruzan to continue certain of Cruzan's business activities, and further desires to own all of the issued and outstanding shares of Cruzan directly rather than through Leaf; and

WHEREAS, the shareholders of each of Cruzan and Leaf have determined that it is in the best interest of each of the companies that Leaf be merged into Cruzan in accordance with applicable laws and upon the terms and subject to the conditions herein stated;

NOW, THEREFORE, in consideration of the premises and the conditions, terms, and provisions set forth in this Agreement, Cruzan and Leaf do hereby agree as follows:

1. MERGER OF LEAF INTO CRUZAN

Leaf will be merged into Cruzan (the "Merger") in accordance with the laws of the U.S. Virgin Islands, with the Merger to be accomplished so as to become effective upon the date of the filing of this Agreement with the office of the Lieutenant Governor of the U.S. Virgin Islands. The surviving party will be Cruzan, which will continue to be governed by and incorporated in accordance with the laws of the U.S. Virgin Islands.

2. EFFECT OF MERGER

Simultaneously with the effective date of the Merger, the separate existence of Leaf will cease and Cruzan will immediately

- (i) succeed, without other transfer, to all the assets, properties, rights, and claims of Leaf, and
- (ii) be subject to all the debts, obligations and liabilities of Leaf,

in the same manner and to the same extent as if such had been owned or incurred by Cruzan itself.

3. OWNERSHIP INTERESTS

All of the outstanding shares of capital stock of Leaf shall be transferred to the shareholders of Cruzan in exchange for all of the outstanding shares of Cruzan, which shall thereupon be owned by the existing shareholders of Leaf. Each outstanding share of capital stock of Leaf shall thereupon be cancelled and retired as a result of the Merger.

4. ACCOUNTING

The accounting of both Leaf and Cruzan shall be merged and shall continue to be carried on the books of Cruzan.

5. GOVERNING DOCUMENTS

The governing documents and agreements of Cruzan, including the articles of incorporation of Cruzan, shall not be amended or modified as a result of the Merger.

6. ADDRESS

The physical address of Cruzan's principal place of business shall remain 3 & 3A Estate Diamond, Frederiksted, St. Croix, U.S. Virgin Islands.

7. APPROVAL

This Agreement, having been submitted for approval to the sole shareholder of Leaf and the sole shareholder of Cruzan, and, having been approved by each, the proper officers of each company shall file all necessary documents and comply with all other legal requirements as may be necessary to accomplish the Merger.

8. EFFECTIVE DATE OF THE MERGER

The Merger shall be effected by the filing of the Agreement of Merger with the office of the Lieutenant Governor of the U.S. Virgin Islands and the Merger and shall be effective upon such filing in accordance with law and this Agreement of Merger.

WHEREFORE, the undersigned, being all of the directors of Leaf Acquisition Ltd., and all of the directors of Cruzan Viril Ltd., respectively, do hereby adopt this agreement as of this 1st day of October, 2008 on behalf of Leaf Acquisition Ltd. and Cruzan Viril Ltd., respectively.
