## ASSIGNMENT OF INTELLECTUAL PROPERTY

Capitalized terms used but not defined herein have the meaning ascribed to them in that certain Asset Purchase Agreement, dated as of the date hereof, by and among Assignors and Assignee (the “**Agreement**”).

Assignee and its successors and assigns are hereby constituted and appointed as Assignors’ true and lawful attorneys with full power of substitution, in Assignors’ name and stead but on behalf and for the benefit of the Assignee and its successors and assigns, to demand and receive any and all of the Transferred Intellectual Property and to give receipts and releases for and in respect of the same, and any part thereof, and from time to time to institute and prosecute, at the expense and for the benefit of the Assignee and its successors and assigns, any and all proceedings at law, in equity or otherwise, or to execute such documents, which Assignee or its successors or assigns may deem proper for the collection or reduction to possession of, or the recordation of ownership to, any of the Transferred Intellectual Property, or for the collection and enforcement of any claim or right of any kind hereby sold, conveyed, transferred and assigned, or intended so to be, and to do all acts and things in relation to the Transferred Intellectual Property which Assignee or its successors or assigns shall deem desirable. The foregoing powers are coupled with an interest and are and shall be irrevocable by any Assignor or by dissolution of any Assignor or in any manner or for any reason whatsoever.

This Assignment is made without representation or warranty, express or implied, by Assignors and is subject to the terms and conditions of the Agreement and such terms and conditions are incorporated herein by this reference. To the extent of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.

This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, successors and assigns.

This Agreement may be executed in multiple counterparts (including facsimile and other electronically transmitted counterparts), each of which shall be deemed an original, but all of which together will constitute one and the same instrument.
