GRANT OF SECURITY INTEREST
PATENTS AND TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, THE E.W. SCRIPPS COMPANY, an Ohio corporation (the “Grantor”), with principal offices at 312 Walnut Street, 2800 Scripps Center, Cincinnati, Ohio 45202 on this 5th day of August, 2009, hereby assigns and grants to SUNTRUST BANK, as Administrative Agent (the “Grantee”) with principal offices at 303 Peachtree Street, NE, 23rd Floor, Atlanta, Georgia 30308, a security interest in (i) all of the Grantor’s right, title and interest in and to the trademarks, trademark registrations, trademark applications and trademark licenses (the “Trademarks”) set forth on Schedule A attached hereto and all reissues, extensions or renewals thereof; (ii) all of the Grantor’s right, title and interest in and to the patents, patent applications and patent licenses (the “Patents”) set forth on Schedule B attached hereto and all reissues, continuations, continuations-in-part and extensions thereof, in each case together with (iii) all Proceeds (as such term is defined in the Pledge and Security Agreement referred to below) of the Trademarks and Patents, (iv) the goodwill of the businesses with which the Trademarks are associated, and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks and Patents or unfair competition regarding the same.




