## Statement Of Conveyance

Pursuant to 37 C.F.R. § 3.25(a)(3), this Statement of Conveyance ("Statement") explains the transfers which have affected title of:

- Reg. No. 2,714,979 (Ser. No. 76/170,753) for THE SCOOTER STORE & Design;
- Reg. No. 2,710,502 (Ser. No. 76/170,751) for THE SCOOTER STORE;
- Reg. No. 2,297,631 (Ser. No. 75/480,070) for TURNING DISABILITIES INTO POSSABILITIES;
- Reg. No. 2,623,482 (Ser. No. 76/170,752) for Design; and
- Reg. No. 2,726,371 (Ser. No. 76/170,829) for SCOOTERS DIRECT FREEDOM DIRECTLY TO YOU

(collectively the "Marks"). Specifically, two conveyances and a change of name transferred the Marks from THE SCOOTER STORE, INC., a Texas Corporation ("TSSI") to THE SCOOTER STORE, LTD., a Texas limited partnership ("TSSL").

1. TSSI to Investments. Under the Blanket Conveyance, Assignment and Assumption Agreement dated December 30, 2001 (the "First Assignment"), TSSI did "sell[], convey[] and assign[]" to TSS INVESTMENTS, INC., a Nevada Corporation ("Investments") "[a]ll intellectual property rights owned by [TSSI]," including all interest and goodwill in and to the Marks.

2. Investments to Holdings. Under the Blanket Conveyance, Assignment and Assumption Agreement dated December 31, 2001 (the "Second Assignment"), Investments did "sell[], convey[] and assign[]" to TSS HOLDINGS, LTD., a Texas limited partnership ("Holdings") "[a]ll intellectual property rights conveyed from [TSSI]," including all interest and goodwill in and to the Marks.

3. Holdings Renamed TSSL. Holdings was renamed as TSSL effective December 31, 2001 at 11:59 pm.
