

MEMORANDUM OF SECURITY AGREEMENT

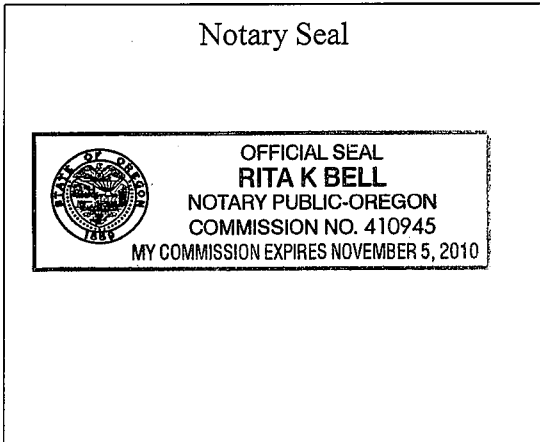
