RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE of Security Interest in Trademark is entered into by **Wells Fargo Foothill, Inc.**, a California corporation ("Lien Holder"), located at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404, in favor of **Webtrends, Inc.**, a Delaware corporation ("Trademark Owner"), having its principal offices at 851 SW 6th Ave., Suite 1600, Portland, Oregon 97204, on July 7, 2009.

RECITALS

Pursuant to that certain Trademark Security Agreement, dated April 29, 2005 (as amended from time to time, the "Trademark Security Agreement"), by and between Lien Holder and Trademark Owner, Trademark Owner granted Lien Holder a security interest in that certain trademark, and the goodwill of the business associated therewith as set forth on Exhibit A (the "Trademark");

The Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 5, 2005, at Reel No. 3078 and Frame No. 0755;

Pursuant to that certain Consent and Partial Release Agreement, dated April 9, 2009, by and between Lien Holder and Trademark Owner, Lien Holder has agreed to release the security interest in the Trademark granted to Lien Holder pursuant to the Trademark Security Agreement (the "Security Interest");

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the parties agree as follows:

1. The Security Interest is hereby released.
2. At Trademark Owner's expense and reasonable request, Lien Holder shall take all lawful acts which Trademark Owner may deem necessary in order to render this release fully effective and to make this release of record in the U.S. Patent and Trademark Office.
