## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made as of July 31, 2009 ("Effective Date") by and between Clean Harbors, Inc., Clean Harbors Environmental Services, Inc. and Harbor Management Consultants, Inc. ("Grantors"), and Credit Suisse, Cayman Islands Branch (f/k/a Credit Suisse First Boston) and its successors, assigns and other legal representatives ("Grantee").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of June 30, 2004, as amended and modified by and between Grantors and Grantee (the "Trademark Security Agreement"), Grantors pledged, assigned and granted to Grantee a continuing security interest in and lien on and right of set-off against all of its right, title and interest in and to its Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the trademark registrations and applications set forth on Schedule A hereto (collectively, the "Trademark Collateral") together with the goodwill associated therewith;

**WHEREAS**, Grantors, certain of their affiliates and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement, dated as of June 30, 2004;

**WHEREAS**, the Trademark Security Agreement and subsequent filings in respect thereof were recorded with the United States Patent and Trademark Office ("PTO") at Reel 003012 Frame 0508 on July 12, 2004;

**AND WHEREAS**, Grantors have paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, re-pledges, reassigns (without representation, warranty or recourse) and releases any and all security interests it has against the Trademark Collateral.

If and to the extent Grantee has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to Grantors AS IS, WHERE IS, without representation, warranty or recourse.

Grantee shall take all further actions, reasonably acceptable to Grantee, and provide to Grantors and each of their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantors, each at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
