ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
LANCE ARMSTRONG FOUNDATION, INC.

Pursuant to the provisions of Article 1396-4.03 of the Texas Non-Profit Corporation Act, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation, filed with the Secretary of State of Texas on January 9, 1997, as amended by Articles of Amendment thereto, filed with the Secretary of State of Texas October 31, 2005:

ARTICLE I

The name of the corporation (the "Corporation") is Lance Armstrong Foundation, Inc.

ARTICLE II

Article One of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

"ARTICLE ONE

**"The name of the corporation (the 'Corporation') is Lance Armstrong
Foundation."**

ARTICLE III

The amendments made by these Articles of Amendment have been effected in conformity with the provisions of the Texas Non-Profit Corporation Act. The Corporation has no members. This amendment was duly adopted at a meeting of the Board of Directors of the Corporation held on December 8, 2005 at which a quorum was present and voting throughout, such amendment having received the affirmative vote of at least a majority of the number of directors then in office.

IN WITNESS WHEREOF, these Articles of Amendment have been executed on Dec. 8, 2005, by the undersigned officer, thereunto duly authorized.
