TERMINATION AND RELEASE OF SECURITY INTEREST IN
TRADEMARK AND PATENT RIGHTS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK AND PATENT RIGHTS ("Agreement"), dated as of June 22, 2009, is given by Laurus Master Fund, Ltd. (In Liquidation) f/k/a Laurus Master Fund, Ltd., a Cayman Islands company, with an address c/o Laurus Capital Management, LLC, 335 Madison Avenue, New York, NY 10017 (the "Lender").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of February 28, 2006, between Small World Toys, Inc. a California corporation (the "Borrower") and Lender, a security interest (the "Security Interest") was granted by the Borrower to the Lender in, among other things, certain Patents and Trademarks (the "Intellectual Property Collateral"), including those set forth on Schedules A and B hereto; and

WHEREAS, the Lender now desires to terminate and release the entirety of its Security Interest granted by Borrower to Lender in and to the Intellectual Property Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Lender hereby terminates and releases the Security Interest granted by Borrower to Lender in the Intellectual Property Collateral.
