ASSIGNMENT AND ASSUMPTION AGREEMENT

This Assignment and Assumption Agreement (the "Agreement") dated as of October 29, 2007 is entered into by and among Tribune Company, a Delaware corporation ("Tribune Parent"), Tribune Interactive, Inc., a Delaware corporation ("Tribune Interactive"), Chicago Tribune Company, an Illinois corporation ("Chicago Tribune") and, collectively with Tribune Parent and Tribune Interactive, "Tribune") and Metromix LLC, a Delaware limited liability company ("Metromix").

WITNESSETH:

WHEREAS, Tribune owns certain assets, rights and properties utilized in or relating to Tribune's establishment of a national entertainment business under the Metromix brand name (the "Business");

WHEREAS, the parties hereto propose that the entire interest of Tribune in the Assets (as hereinafter defined) be transferred to Metromix as hereinafter provided, and that the Metromix Liabilities (as hereinafter defined) be assumed by Metromix;


CONVEYANCE OF ASSETS TO METROMIX




