CONFIRMATORY GRANT OF TRADEMARK SECURITY INTEREST

CONFIRMATORY GRANT OF TRADEMARK SECURITY INTEREST ("Confirmatory Grant"), dated as of August 10, 2009, by and between TIPPMANN SPORTS, LLC, a Delaware limited liability company ("Grantor"), in favor of GOLUB CAPITAL INCORPORATED, in its capacity as administrative agent for certain lenders ("Administrative Agent").

WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of the date hereof by and among Grantor, Administrative Agent, Golub Capital Incorporated, as revolver agent, and the Persons signatory thereto from time to time as Lenders (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Loan Agreement"), the Lenders have agreed to make Loans and to extend Letters of Credit for the benefit of Grantor;

WHEREAS, as security for all Obligations, pursuant to the terms of the Loan Agreement, Grantor granted to Administrative Agent, for the benefit of Agents, L/C Issuers and the Lenders, a continuing security interest in, lien on, and right of set-off against all Trademarks of Grantor, whether now owned or existing or hereafter acquired or arising; and

WHEREAS, pursuant to the Loan Agreement, Grantor is required to execute and deliver to Administrative Agent, for Agents and the ratable benefit of Lenders, this Confirmatory Grant.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

1. **DEFINED TERMS.** All capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan Agreement.

2. **GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL.** Grantor hereby grants to Administrative Agent, on behalf of Agents, L/C Issuers and the Lenders, a continuing first priority security interest in, and lien upon, all of Grantor's presently existing or hereafter acquired right, title and interest in and to the Trademarks, including, without limitation, the Trademarks set forth on Schedule A hereto, and all proceeds and products thereof.

3. **LOAN AGREEMENT.** The security interests granted pursuant to this Confirmatory Grant are granted in conjunction with, and not in limitation of, the security interests granted to Administrative Agent, on behalf of Agents, L/C Issuers and the Lenders, pursuant to the Loan Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Administrative Agent with respect to the security interest in the Trademarks and related Collateral made and granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. GOVERNING LAW. This Confirmatory Grant shall be governed by and construed in accordance with the internal laws of the State of New York without giving effect to its choice of law provisions.
