**RELEASE AND TERMINATION  
OF  
TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Trademark Security Agreement, dated March 4, 2008 (the "Trademark Security Agreement") was executed by ROSENTHAL U.S.A. LIMITED ("Grantor"), covering the Trademarks and Trademark Applications more fully described on Exhibit A annexed hereto and made a part hereof in favor of BANK OF AMERICA, in its capacity as agent ("Secured Party") pursuant to the Facility Agreement (as hereinafter defined) acting for and on behalf of the parties thereto as lenders (each individually, a "Lender" and collectively, "Lenders"). Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Trademark Security Agreement.

Grantor has requested and the Secured Party has agreed to release the Trademark Collateral and discharge the Trademark Security Agreement.


