**ASSIGNMENT OF IP SECURITY AGREEMENT**

This **ASSIGNMENT OF IP SECURITY AGREEMENT** (this "Assignment") is executed as of July 1, 2009, by **TEXTRON FINANCIAL CORPORATION**, a Delaware corporation ("Textron"), in its capacity as lender immediately prior to the effectiveness of the below-defined Assignment and Assumption Agreement (in such capacity, "Assignor") in favor of Assignee (as defined below). Capitalized terms used herein but not defined herein shall have the respective meanings assigned to such terms in the Loan Agreement referred to below.

**WITNESSETH:**

**WHEREAS**, Storeroom Solutions, Inc., a Pennsylvania corporation ("Borrower") entered into that certain Amended and Restated Loan and Security Agreement, dated as of March 26, 2007 (as amended, restated, supplemented, or otherwise modified from time to time, the "Loan Agreement"), by and among Borrower and Textron, as Lender;

**WHEREAS**, Borrower entered into that certain Patent, Copyright and Trademark Collateral Assignment and Security Agreement, dated as of April 1, 2003 (as amended, restated, supplemented, or otherwise modified from time to time, the "IP Security Agreement"), by and among Borrower and Textron, concerning the Intellectual Property Collateral (as defined in the IP Security Agreement), including the Trademarks, Patents, Trade Names and Copyrights (each, as defined in the IP Security Agreement) listed on Schedule 1 attached hereto, which IP Security Agreement was recorded with the United States Patent and Trademark Office on July 18, 2003 as Reel/Frame Number 002780/0038 and the Copyright listed on Schedule 1 was registered with the United States Copyright Office on May 7, 2002;

**WHEREAS**, Assignor and Wells Fargo Bank, N.A. ("Assignee") are parties to that certain Assignment and Assumption Agreement, dated as of June 4, 2009 (the "Assignment Agreement"), pursuant to which Assignor has assigned all of its right, title and interest in and to the Loan Documents to Assignee; and

**WHEREAS**, in connection with the Assignment Agreement, Assignee has requested that Assignor enter into this Assignment;

NOW, THEREFORE, the parties hereto hereby agree as follows:

1. **Assignment.** Assignor, for good and adequate consideration described in the Assignment Agreement, the receipt and sufficiency of which are hereby acknowledged, hereby assigns, without recourse, representation or warranty of any kind, as of the Effective Date (as defined in the Assignment Agreement) to Assignee all of the rights, title and interest of Assignor in, to and under the IP Security Agreement.
2. **Further Assurances.** Assignor agrees to cooperate with Assignee and take all actions reasonably requested by Assignee in order to fully carry out the terms of this Assignment or to permit Assignee to obtain the full benefits of this Assignment.


