THIS ASSIGNMENT is made on *16 April* 2008

**BETWEEN:**

- (1) **FOSECO INTERNATIONAL LIMITED** (No. 00468147) whose registered office is at Coleshill Road, Fazeley, Tamworth, Staffordshire B78 3TL ("**Assignor**"); and
- (2) **RHI AG** a company incorporated under the laws of Austria whose registered office is a Wienerbergstrasse II, A-1100, Vienna, Austria ("**Assignee**").

**RECITALS**

- (A) On 11 October 2007, the boards of Cookson Group plc and Foseco plc ("**Foseco**") announced that they had reached agreement on the terms of a recommended cash offer by Cookson Group plc for the entire issued and to be issued share capital of Foseco plc ("**Foseco Acquisition**").
- (B) Pursuant to, and subject to the provisions of, the Business Sale Agreement (as defined below), Cookson Group plc has agreed to procure the sale of and RHI Refractories UK Limited, Veitsch-Radex America Inc and Refractory Intellectual Property GmbH & Co. KG have agreed to purchase the carbon bonded ceramics business carried on by Foseco and its subsidiary undertakings from time to time ("**Business**") subject to the completion of the Foseco Acquisition.
- (C) By a letter of instruction dated *16* April 2008 RHI Refractories UK Limited, Veitsch-Radex America Inc and Refractory Intellectual Property GmbH & Co. KG have informed Cookson Group plc that the Business Intellectual Property (as defined in the Business Sale Agreement) should be transferred to the Assignee.
- (D) The Assignor, wishes to assign the IPR (as defined below) to the Assignee.

**NOW THIS ASSIGNMENT WITNESSES AS FOLLOWS:**

**1. DEFINITIONS AND INTERPRETATION**

**1.1** The following terms will have the following meanings:

"**Application**" means any pending patent applications, any published patents and any patents that have not yet been registered which are listed in schedule 2 of this agreement;

"**Business Sale Agreement**" means the agreement entered into by (1) Cookson Group plc (2) RHI Refractories UK Limited (3) Veitsch-Radex America Inc and (4) Refractory Intellectual Property GmbH & Co KG on the 11 January 2008;

"**Designs**" means the registered designs and design applications set out in schedule 3 of this agreement;

"**Effective Date**" means the date hereof;

"**IPR**" means the Patents, the Designs and the Trade Marks;

"**Patents**" means:

- (a) the patents set out in schedule 2 of this agreement;
- (b) the Applications and any patents which may be granted pursuant to the Applications;

- (c) any pending European Patent Office oppositions to patents brought by the Assignor exclusively for the benefit of the Business to the extent that the Assignor is able to procure the transfer of such oppositions; and
- (d) the inventions embodied in the case numbers in schedule 2 having a status of "To be filed"; and

"Trade Marks" means the registered trade marks or applications for registered trade marks set out in schedule 1 of this agreement.

1.2 In this agreement, unless otherwise expressly specified:

- (a) a reference to a statute or statutory instrument or any of their provisions is to be construed as a reference to that statute or statutory instrument or such provision as the same may have been or may after the Effective Date be amended or re-enacted;
- (b) grammatical variants of terms defined in clause 1.1 will bear their corresponding meanings; and
- (c) "this agreement" includes the schedules to it.

## 2. ASSIGNMENT AND CONSENT

In consideration of £ 544,998.50 receipt of which is acknowledged by the Assignor, the Assignor assigns its respective rights and interests in the IPR to the Assignee including all the goodwill attaching to and represented by the Trade Marks, but no other goodwill, and all statutory and common law rights to sue for past infringements and to retain any damages obtained as a result of such action.

## 3. BUSINESS SALE AGREEMENT

Nothing in this agreement will affect the scope of the warranties given in the Business Sale Agreement, including the warranties in Paragraph 2 of Schedule 12, nor the provisions of Clause 8.4.3.

## 4. COUNTERPARTS

This agreement may be entered into in any number of counterparts, all of which taken together shall constitute one and the same instrument.

## 5. FURTHER ASSURANCE

The Assignor hereby covenants with the Assignee that the Assignor will, without undue delay, execute, sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee, to enable the Assignee to enjoy the full benefit of the rights hereby assigned. This shall include but not be limited to the execution of such further documents as the Assignee may require to enable the Assignee to become registered as legal proprietor of the IPR.

## 6. GOVERNING LAW AND JURISDICTION

- 6.1 This agreement and any dispute will be governed by and construed in accordance with English law.
- 6.2 Each party irrevocably agrees that the courts of England will have exclusive jurisdiction to hear, decide or settle any disputes and for these purposes, each party irrevocably submits to the jurisdiction of the courts of England.

The parties have witnessed this agreement by signing below via their respective duly authorised representatives on the date at the head of this agreement.



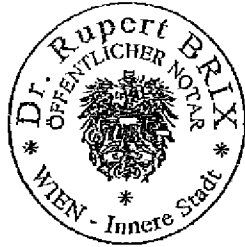
