**Under Section 905 of the Business Corporation Law of the State of New York**

Pursuant to Section 905 of the Business Corporation Law of the State of New York (the "NYBCL"), the undersigned does hereby certify this 19th day of December, 2008 that:

FIRST. The name and place of organization of each constituent entity is as follows:

(a) Source Acquisition Corp., a Delaware corporation ("Source"), which is a wholly owned subsidiary of Avnet, Inc. and has not filed an Application for Authority in New York.

(b) Avnet, Inc., a New York corporation ("Avnet").

The name of the surviving corporation is Avnet, Inc., a New York corporation (the "Surviving Corporation"), which was originally incorporated under the name of "Avnet Electronic Supply Co., Inc."

SECOND. Source has an authorized capitalization of 100 shares of capital stock, of which all are designated as common stock, of which 100 are issued and outstanding. Each share of common stock is entitled to one vote. All of such shares of common stock are owned by Avnet.

THIRD.

(a) In compliance with the NYBCL, the Agreement and Plan of Merger providing for the merger of Avnet's wholly owned subsidiary, Source, into Avnet (the "Merger") was approved by the Board of Directors of Avnet on November 6, 2008.

(b) In compliance with the General Corporation Law of the State of Delaware, the Agreement and Plan of Merger providing for the Merger was approved by the Board of Directors of Source on November 6, 2008. The merger is permitted under the laws of the jurisdiction of incorporation of the subsidiary corporation and is in compliance therewith.

FOURTH.

(a) The Certificate of Incorporation of Source was filed with the Secretary of State of the State of Delaware on January 24, 2001 under the name "Source Acquisition Corp."

(b) The Certificate of Incorporation of Avnet was filed with the Secretary of State of the State of New York on July 22, 1955.

**FOURTH:** The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.

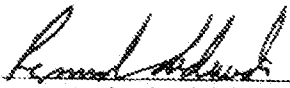
**FIFTH:** The merger is to become effective on December 31, 2008.
