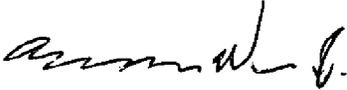
Article I. The exact name of the corporation is The Warren Group, Inc.

A. to engage in gathering, publishing, and distributing information regarding real estate and banking, and to organize conferences and events, and

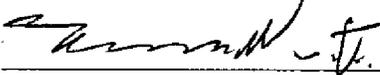
