The Assignor hereby assigns, transfers and conveys to the Assignee, and the Assignee hereby accepts and assumes, free and clear of any encumbrances, all right, title and interest in and to the trademarks as described on Attachment A hereto, together with the goodwill of the business symbolized by the trademarks, the applications for registration and registrations therefor, and all claims for damages arising out of or relating to past or continuing infringements thereof, if any, with the right to sue for and collect such damages.

2. The rights assigned hereby include, without limitation all of the Assignor's right to sue and recover for any past, present, and future infringement or unauthorized use of any right or interest in the trademarks.

3. Assignor hereby authorizes and requests the Commissioner of Trademarks of the United States Patent and Trademark Office, and any foreign trademark authority, to record this Assignment and hereby represent and warrant that the Assignor have the full right to convey the entire interest herein assigned.

4. Assignor agrees to execute any further lawful documents and take any other actions that the Assignee may consider necessary or appropriate to fully protect and vest in the Assignee the assigned rights and interests in the trademarks and to assist the Assignee in the registration, maintenance, perfection and enforcement of any of the trademarks.

5. This Agreement shall be governed by, and construed in accordance with the laws of the State of New York without giving effect to conflicts of law principles thereof.



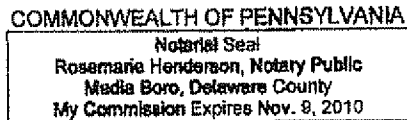

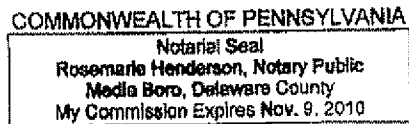
