TRADEMARK ASSIGNMENT

Assignor hereby represents and warrants to Assignee that Assignor has not heretofore sold, transferred, assigned or encumbered any of its right, title or interest in the Trademarks, and that it has the authority to transfer and assign the Trademarks and associated goodwill and enter into this Assignment and perform its obligations hereunder.
