ASSIGNMENT OF TRADEMARK RIGHTS

This ASSIGNMENT OF TRADEMARK RIGHTS, effective as of August 13, 2009 (the "Effective Date"), is from C.T.A. Acoustics, Inc., a Delaware corporation with a business address of 25211 Dequindre Road, Madison Heights, Michigan 48071 ("ASSIGNOR"), to Corbin Fiber Products, LLC, a Delaware limited liability company with a business address of 100 CTA Blvd., Corbin, Kentucky 40701 ("ASSIGNEE").

WITNESSETH:

WHEREAS, ASSIGNOR is the sole owner of the exclusive right, title and interest in and to the common law trademark 60° PLUS, and the related trademark application currently pending with the United States Patent & Trademark Office ("PTO"), that being Application Serial No. 77/707,197 for the mark 60° PLUS (hereinafter collectively referred to as "the Marks");

WHEREAS, ASSIGNEE is a wholly owned subsidiary of ASSIGNOR and successor to the business of ASSIGNOR and/or a successor to the ongoing and existing portion of the business to which each of the Marks pertains, thus making assignment of the Marks permissible under Section 10 of the Lanham Act;

WHEREAS, ASSIGNEE is interested in acquiring the entire and exclusive right, title and interest in and to the Marks together with the goodwill of the business connected with the use of and symbolized by the Marks;

WHEREAS, ASSIGNOR desires to assign to ASSIGNEE, and ASSIGNEE desires to receive from ASSIGNOR, the entire and exclusive right, title and interest in and to the Marks, together with the goodwill of the business connected with the use of and symbolized by the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby sells, assigns, transfers and sets over to ASSIGNEE its entire right, title and interest in and to the Marks, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for ASSIGNEE's own use and enjoyment, and for the use and enjoyment of ASSIGNEE's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, and further including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for and collect the same for ASSIGNEE's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.
