**TERMINATION AND RELEASE OF SECURITY INTEREST
IN CERTAIN TRADEMARKS**

TERMINATION AND RELEASE dated as of August 13, 2009, from Wilmington Trust FSB, a federal savings bank (as assignee of Credit Suisse), as Administrative Agent (in such capacity, the "Agent") for certain banks and other financial institutions (the "Lenders"), to Krause Publications, Inc., a Wisconsin corporation with its principal place of business located at 700 East State Street, Iola, Wisconsin 54990.

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of August 5, 2005, made by the Grantors (as defined therein) in favor of the Agent (as the same may have been amended, restated, supplemented or otherwise modified as of the date hereof, the "Collateral Agreement"), a second lien security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including certain Trademarks (as defined therein);

WHEREAS, the Collateral Agreement was recorded in the United States Patent and Trademark Office on October 7, 2005, 2005 at Reel 3171 Frame 0762 and on March 30, 2009 at Reel 3961, Frame 0592; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions: The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof solely in the Trademarks listed on Schedule A hereto. The term "Trademarks" shall have the meaning provided by reference in the Collateral Agreement.

2. Release of Security Interest: The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.


3. Further Assurances: The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
