## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated and effective as of August 5, 2009 (the "Effective Date"), is made by D.B. Zwirn Special Opportunities Fund, LLC, a Delaware limited liability company and the successor in interest to D.B. Zwirn Special Opportunities Fund, L.P.), by itself and in its capacity as Administrative Agent and Collateral Agent pursuant to the Financing Agreement and Security Agreements, as defined below ("Zwirn"). Capitalized terms used but not defined in this Release will have the meanings given to them in the Financing Agreement and the Security Agreements.

### RECITALS

- A. Zwirn is a party to that certain Financing Agreement, dated as of February 18, 2005 (the "Financing Agreement") among Avid Health, Inc., Supplement Sciences, Inc., Nutrition Now, Inc. and Northwest Natural Products, Inc. (each a "Grantor" and collectively, the "Grantors"), Zwirn (as Collateral Agent and Administrative Agent for the Lenders), and each of the Lenders.
- B. In connection with the Financing Agreement, the Grantors granted to Zwirn (for the benefit of the Agents and the Lenders) security interests in the Grantors' Intellectual Property, including the Intellectual Property listed on Exhibit A to this Release, pursuant to that certain Security Agreement, dated as of February 18, 2005 made by the Grantors, and pursuant to specific Assignments for Security executed by the Grantors, which were recorded by Zwirn with the United States Patent and Trademark Office ("USPTO") and the United States Copyright Office (the "Security Agreements").

### TERMS AND CONDITIONS

1. For valuable consideration, the receipt of which is hereby acknowledged, Zwirn (on behalf of itself, the Agents and the Lenders) hereby releases, without representation, warranty or recourse, all of its security interest in all of the Grantors' Intellectual Property, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Financing Agreement, and Zwirn (on behalf of itself, the Agents and the Lenders) hereby reassigns to the Grantors any and all such right, title and interest (if any) that Zwirn (or the Agents or Lenders) may have in the Grantors' Intellectual Property.
2. Zwirn agrees (on behalf of itself and the Lenders) to cooperate with the Grantors and to execute, acknowledge and deliver such further releases, termination statements, assignments and other assurances pursuant to this Release as may be reasonably requested by Grantors in order to effectuate the complete release of such parties' security interests in the Intellectual Property. Zwirn authorizes Grantors to file this Release with the USPTO and the United States Copyright Office, and any other authority or office as may be necessary to effectuate this Release.
