RESTATED CERTIFICATE OF INCORPORATION
OF
MISYS INTERNATIONAL BANKING SYSTEMS INC.

Under section 807 of the Business Corporation Law

It is hereby certified that:

FIRST: (a) The present name of the corporation (herein after called the "Corporation") is MISYS INTERNATIONAL BANKING SYSTEMS INC.

(b) The name under which the Corporation was originally incorporated is "The Frustum Group, Inc."; and the date of filing the original Certificate of Incorporation of the Corporation with the Secretary of State of the State of New York is September 18, 1991; and

(c) (i) The original name of the Corporation was changed from "The Frustum Group, Inc." to "Misys International Banking Systems (White Plains) Inc."; and the date of filing of the Certificate of Amendment of Certificate of Incorporation with the Secretary of State of the State of New York is January 15, 2002; and

(ii) The name of the Corporation was subsequently changed from "Misys International Banking Systems (White Plains) Inc." to "Misys International Banking Systems Inc."; and the date of filing of the Certificate of Merger which resulted in said change of corporate name with the Secretary of State of the State of New York is May 22, 2003.

SECOND: The provisions of the Certificate of Incorporation of the Corporation as heretofore amended and/or supplemented, are hereby restated and integrated into the single instrument which is hereinafter set forth, and which is entitled RESTATED CERTIFICATE OF INCORPORATION OF MISYS INTERNATIONAL BANKING SYSTEMS INC., without further amendment and without any discrepancy between the provisions of the Certificate of Incorporation as heretofore amended and supplemented and the provisions of said single instrument hereinafter set forth.

Under Section 402 of the Business Corporation Law

IT IS HEREBY CERTIFIED THAT:

1. The name of the corporation is :

MISYS INTERNATIONAL BANKING SYSTEMS, INC.

2. The purpose or purposes for which the corporation is formed are as follows; to wit:

To engage in any lawful act or activity for which corporations may be formed under the Business Corporation Law. The corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.

To own, operate, manage, acquire and deal in property, real and personal, which may be necessary to the conduct of the business.

The corporation shall have all of the powers enumerated in Section 202 of the Business Corporation Law, subject to any limitations provided in the Business Corporation Law or any other statute in the State of New York.

3. A director of the corporation shall not be held liable to the corporation or its shareholders for damages for any breach of duty in such capacity except for

(i) liability if a judgment or other final adjudication adverse to a director establishes that his or her acts or omissions were in bad faith or involved intentional misconduct or knowing violation of law or that the director personally gained in fact a financial profit or other advantage to which he or she was not legally entitled or that the director's acts violated BCL Section 719, or

(ii) liability for any act or omission prior to the adoption of this provision.

4. The county in which the office of the corporation is to be located in the State of New York is: New York


5. The aggregate number of shares which the corporation shall have authority to issue is: 2000 shares, no par value.

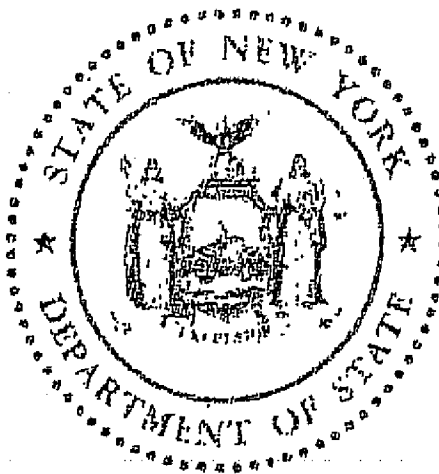
