TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Fisher Mills Inc., a Washington corporation ("FMI"), Fisher Communications, Inc., a Washington corporation ("FCI") (collectively, "Sellers"), and Conifer Specialties, Inc., a Washington corporation ("Buyer"), have entered into a Trademark Purchase and Assignment Agreement ("Purchase Agreement"), dated August 21, 2009, pursuant to which Sellers have agreed to assign, and the Buyer has agreed to receive, certain assets;

ASSIGNMENT


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:


