**INTELLECTUAL PROPERTY  
ASSIGNMENT AGREEMENT**

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Assignment") is made as of the 2nd day of July, 2007 by and between **ICOMPLY INCORPORATED**, a District of Columbia corporation ("Assignor"), and **THOMSON LEGAL & REGULATORY INC.**, a Minnesota corporation ("Assignee"). This Assignment is being entered into pursuant to the Asset Purchase Agreement between Assignor, Robert Lotstein, the sole shareholder of Assignor, and Assignee, dated as of the date hereof (the "Purchase Agreement").

Now therefore, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge, the parties agree as follows:

1. Assignor hereby assigns, conveys, transfers and delivers to Assignee all of Assignor's right, title and interest in and to the Assigned IP, together with the goodwill associated therewith, the right, if any, to secure all renewals and extensions thereof in all countries, and the right to sue and recover for, and the right to profits or damages due, accrued, arising out of or in connection with, any and all past, present or future infringements or dilution of, or damage or injury to the Assigned IP or the accompanying goodwill.

2. Assignor agrees that, upon the Assignee's reasonable request it will furnish all necessary documentation reasonably available to Assignor relating to or supporting chain of title, sign all appropriate papers, take all rightful oaths, and do all rightful acts which may be reasonably necessary for vesting title to, and effecting the transfer and recording of, the Assigned IP in Assignee, its successors, assigns and legal representatives or nominees.
