ORDER GRANTING COMMERCE CAPITAL, L.P.
RELIEF FROM THE AUTOMATIC STAY

This matter coming before the Court for hearing on Commerce Capital, L.P.'s Motion For Relief From Automatic Stay (the "Motion"), due and proper notice of the Motion having been given, it appearing that there is good cause to grant the relief requested, and the Court being duly advised in the premises,

IT IS HEREBY ORDERED THAT:

1. The relief requested in Commerce Capital, L.P.'s Motion is granted.
2. The automatic stay imposed pursuant to 11 U.S.C. § 362(a) is modified to permit Commerce Capital, L.P. to enforce its security interest and foreclose on its lien through a UCC sale of the collateral that is securing its \$ [REDACTED] loan to the Debtor.
3. The stay provisions of Rule 4001(a)(3) of the Federal Rules of Bankruptcy Procedure are waived and this Order is effective immediately.
