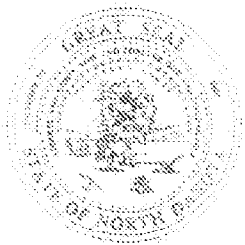

The amendment does not require an exchange, reclassification, division, combination or cancellation of membership interests.

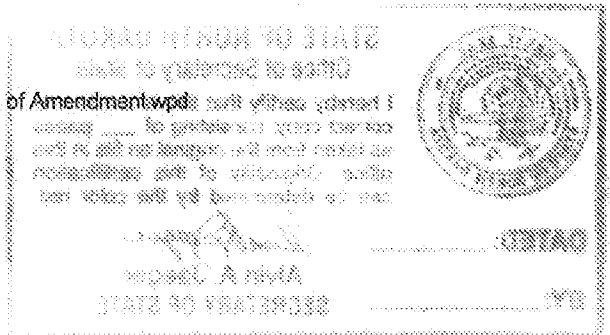
