TERMINATION OF
TRADEMARK GRANT OF SECURITY AGREEMENT

This Termination of Trademark Grant of Security Agreement (the "Termination"), dated as of August 25, 2009, is executed by Hercules Technology II, L.P. ("Secured Party") in favor of Coveroo, Inc., (successor by merger of Wallop Technologies, Inc.) a Delaware corporation (the "Company").

RECITALS

WHEREAS, the Company and the Secured Party entered into that certain Equipment Loan and Security Agreement dated as of May 27, 2007, and Amendment No. 1 to the Equipment Loan and Security Agreement dated as of April 1, 2009 (collectively, the "Loan Agreement"); and

WHEREAS, in connection with Loan Agreement, the Company entered into that certain Intellectual Property Security Agreement dated as of April 1, 2009 (the "Assignment"); and

WHEREAS, pursuant to the Assignment, the Company granted to the Secured Party a security interest in certain "Collateral" including certain trademarks; and

WHEREAS, certain of the Collateral in Loan Agreement has been released, including all of the trademarks described in the Assignment. Accordingly, the Assignment is to be terminated.

NOW, THEREFORE, the Secured Party agrees as follows:


1. The Secured Party is executing and delivering this Termination as evidence of the termination of the Assignment.
2. The Secured Party claims no right title or interest whatsoever in or to any of the "Collateral" described in the Assignment and the Secured Party expressly terminates its security interest in the trademarks listed on Schedule I hereto.
