ARTICLES OF INCORPORATION OF  
IMEDICA CORPORATION**

The undersigned, Michael Nissenbaum and Neil Simon, hereby certify that:

1. They are the duly elected and acting President and Secretary, respectively, of iMedica Corporation, a California corporation.
2. The Articles of Incorporation of said corporation were originally filed with the Secretary of State of the State of California on July 9, 1998 under the name "iMedica Corporation"
3. Article I of the corporation's Sixth Amended and Restated Articles of Incorporation is amended in its entirety to read as follows:

“ ARTICLE 1

The name of this Corporation is Aprima Medical Software, Inc. (the  
“Company”).”

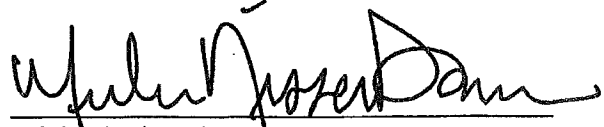
4. This Certificate of Amendment of the Company's Sixth Amended and Restated Articles of Incorporation has been duly approved by the Company's Board of Directors in accordance with Section 902 the California Corporations Code.

5. This Certificate of Amendment of the Company's Sixth Amended and Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The total number of outstanding shares of Common Stock of the Company is 3,734,131, and the total number of outstanding shares of Preferred Stock of the Company is 55,093,770. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was a majority of the outstanding shares entitled to vote.

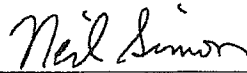
