RELEASE

In consideration of the payment of all indebtedness and amounts secured by that certain Trademark Security Agreement made as of June 27, 2003, by and between Milton's Inc., a Massachusetts corporation, with a principal place of business at 250 Granite Street, Braintree, Massachusetts 02184 (the "Borrower"), and Wells Fargo Bank, National Association (successor to Wells Fargo Business Credit, Inc., acting through its Wells Fargo Business Credit operating division, with a usual place of business at 300 Commercial Street, Boston, Massachusetts 02108 (the "Bank"), which Trademark Security Agreement was filed with the United States Patent and Trademark Office on July 7, 2003, and recorded in Reel 002773, Frame 0420, et seq., of the Trademark Assignment Records, the Bank hereby releases and discharges all of its right, title and interest in and to the above-described Trademark Security Agreement, including the security interest and conditional assignment created and existing thereunder on the property described in and covered thereby, and reassigns to the Borrower any right, title and interest of the Bank in and to the "Collateral" described therein, including the right to recover for past infringement of any of the Collateral and the goodwill of the business in connection with which the Collateral is used and which is symbolized by any of the Collateral.

Reference is made to the above-described Trademark Security Agreement and the recordation thereof for all purposes in connection herewith.


