TRADEMARK ASSIGNMENT

This Trademark Assignment (“**Trademark Assignment**”) dated as of August 26, 2009 (the “**Effective Date**”), is made by The Denver Post Corporation, a Delaware corporation (“**Assignor**”), in favor of The Denver Newspaper Agency LLC, a Delaware limited liability company (formerly (prior to a statutory conversion) The Denver Newspaper Agency LLP, a Delaware limited liability partnership) (“**Assignee**”). Capitalized terms used and not otherwise defined herein shall have the meanings assigned to such terms in the Contribution Agreement (as defined below).

WHEREAS, pursuant to that certain Contribution Agreement (the “Agreement”) among MediaNews Group, Inc., a Delaware corporation (“MNG”), Assignor and Assignee entered into as of August 26, 2009, Assignor has agreed to sell, assign, transfer and convey to Assignee all of its right, title and interest in and to the DPC Intellectual Property, including, without limitation, the Trademarks set forth on Schedule A hereto (the “**Assigned Marks**”).

NOW, THEREFORE, in consideration and in exchange for the sum of \$1.00 paid in hand to Assignor by Assignee, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and agrees as follows:

1. Assignor does hereby irrevocably assign, transfer, convey and deliver to Assignee, its successors, assigns and other legal representatives, the entire right, title and interest throughout the world in and to: (a) each of the Assigned Marks and all applications and registrations relating thereto, (b) the goodwill of the business symbolized by and associated with the Assigned Marks, (c) all rights to proceeds, including, without limitation, damages, claims, income, and payments, whether presently existing or hereafter arising, relating to or arising out of the Assigned Marks, (d) all claims, demands and causes of action (in law or in equity) for past, present and future damages arising out of or relating to infringement of the Assigned Marks, (e) all rights to sue, counterclaim, and recover for past, present, and future damages arising out of or relating to the Assigned Marks, and (f) all rights corresponding to the foregoing throughout the world.

2. Assignor hereby acknowledges and agrees that from and after the date hereof, Assignee shall be the exclusive owner of the Assigned Marks.

3. Assignor shall, at the request of Assignee or its successors, assigns and legal representatives, take such further action and execute such additional agreements and instruments as may be necessary to effect the assignment contemplated hereby and to perfect Assignee’s title in and to the Assigned Marks. In addition, upon request, Assignor shall provide Assignee and its successors, assigns and legal representatives reasonable cooperation and assistance in the prosecution or defense of any proceeding that may arise in connection with any of the rights assigned hereby.

IN WITNESS WHEREOF, Assignor has caused this Trademark Assignment to be duly authorized and executed as of the Effective Date.

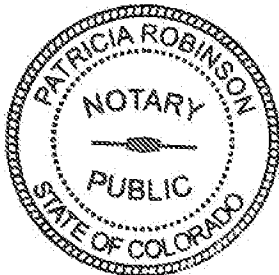
