RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on August 31, 2009, by Bank of America, N.A., as the administrative agent (in such capacity, the "Administrative Agent") to SPTC, Inc., a Nevada corporation (the "Borrower").

WHEREAS, on September 7, 2005, the Borrower entered into an Intellectual Property Security Agreement in favor of the Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"; capitalized terms used herein but not defined herein shall have the meaning set forth in the Security Agreement);

WHEREAS, said Security Agreement was recorded in the United States Patent and Trademark Office on October 3, 2005 at reel/frame 3169/590; and

WHEREAS, the Administrative Agent now wishes to release its security interest in the Borrower's right, title and interest in, to and under the Trademarks and transfer and assign to the Borrower, without recourse, representation or warranty of any kind, all of the Administrative Agent's right, title and interest in and to the Borrower's right, title and interest in, to and under the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Administrative Agent and the Borrower, the Administrative Agent hereby releases any security interest it may have in the Borrower's right, title and interest in, to and under the Trademarks granted pursuant to the Security Agreement or any other Loan Document (used herein as defined in the Credit Agreement), and assigns any and all right, title and interest it may have pursuant to the Security Agreement or any other Loan Document in the Borrower's right, title and interest in, to and under the Trademarks, without recourse, representation or warranty of any kind, to the Borrower.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
