AGREEMENT

This AGREEMENT (this "Agreement") is made and entered into as of January 1, 2008, by and between Founders Fund LLC, a Delaware limited liability company ("Transferee"), and The Founders Fund Management LLC, a California limited liability company (the "Transferor," and together with Transferee, the "Parties" and each a "Party").

The Parties, intending to be legally bound hereby, agree as follows:

1. Trademark Assignment.

For good and valuable consideration, the receipt of which is hereby acknowledged, Transferor hereby assigns, transfers, conveys and delivers to Transferee, all of its rights, title and interest in and to the trademarks FOUNDERS FUND and FF PREFERRED STOCK and all trademark applications and registrations therefor (including but not limited to US PTO application numbers 77/228,707, 77/228,698, 77/228,690) that it may possess or hereinafter possess (collectively, the "Trademarks"); the goodwill associated therewith; and, including without limitation, its right to sue for and collect damages for infringement or other violations of the same, including for past infringements or other violations. The Parties acknowledge that Transferee is the successor to the ongoing and existing business of Transferor, or to the portion of the ongoing and existing business of Transferor to which the Trademarks pertain.

2. Miscellaneous.

(a) **Integration; Severability.** This Agreement, including any exhibits hereto, constitutes the complete, final and exclusive embodiment of the Parties' agreement with respect to the subject matter hereof and supersedes all prior agreements, whether written or oral, which may have been entered into between the Parties on the subject matter hereof. Any term of this Agreement may be amended or waived only with the written consent of Transferor and Transferee. The invalidity or unenforceability of any provision hereof shall in no way affect the validity or enforceability of any other provision.

(b) **Titles and Subtitles.** The titles and subtitles used in this Agreement are used for convenience only and are not to be considered in construing or interpreting this Agreement.

(c) **Counterparts.** This Agreement may be executed and delivered by facsimile signature and in multiple counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
